### 1. Purpose of Report

The purpose of this report is to update the Overview, Scrutiny and Policy Development Committee on proposed new measures to monitor the performance of the Our North Tyneside Plan 2021-2025 and the committee is invited to make any comments or provide feedback on proposed measures.

### 2. Recommendations

The Committee is invited to:-

- a) Note the proposed performance measures to monitor progress of the Our North Tyneside Plan 2021-2025 as attached in Appendix 1
- b) Provide any comments or recommendations to consider as appropriate.

### 3. Details

On 23<sup>rd</sup> September 2021, the new council plan, Our North Tyneside Plan 2021-25 was agreed by Full Council. The new council plan reflects the policy priorities of the incoming administration following the Mayoral Election in May 2021 and the priorities of residents, businesses, partners and stakeholders provided during internal and external engagement.

The Our North Tyneside Plan is structured around five themes with a set of policy priorities:-

- Thriving
- Family Friendly
- Caring
- Secure
- Green

The Our North Tyneside Plan sets out the strategic priorities and vision for the council, however it will require partnership working with residents, communities, businesses, other local public sector organisations and the voluntary and community sector to realise the priorities set out. The Our North Tyneside Council Plan has been adopted as the strategic vision of the North Tyneside Strategic Partnership.

A proposed set of high-level outcome measures (appendix 1) have been developed against most of the priorities of the Our North Tyneside Plan. The majority of measures are updated annually. For some priorities, such as regeneration projects, a written qualitative update would be more appropriate than performance metrics.

The Our North Tyneside 2021-2025 performance report will be produced on a 6 monthly basis and will be presented to Lead Member Briefing, Overview, Scrutiny and Policy Development Committee and the North Tyneside Strategic Partnership.

The proposed format for this report is a dashboard report with an accompanying analysis report.
