- Could be developed in the future to provide replacement facilities for NSVL.

- If the pool is not refurbished then what is there needs to be removed.

- We demolished the Plaza, we must not do the same to the pool.

- It would be nice for the Council to engage in some better planning options.

- Give the residents a facility to be proud of and make up for your previous

incompetence in dealing with this proposal over the last 5-6 years.

- There is a general loss of public swimming facilities due to cost and this facility will be a welcome addition.

- I would be more than happy to assist on a voluntary basis in constructing the pool.

- The council could initiate a world leading sustainable outdoor swimming pool.

- There seems to be a general trend towards either creating new outdoor pools/lidos or restoring old ones.

- There is an open-air pool in Stonehaven, near Aberdeen.

- Support the idea but think the design is very poor.
