## LICENSING ACT 2003

### NORTH TYNESIDE COUNCIL

#### PROCEDURE FOR HEARING OF AN APPLICATION FOR REVIEW BEFORE THE LICENSING SUB-COMMITTEE (“the Committee”)

The four licensing objectives, as set out in the Licensing Act 2003, are:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm.

Each application that comes before this Committee will be treated on its own merits, and this Licensing Authority will take its decision based upon:

- The merits of the Application
- The promotion of the four licensing objectives
- The statement of Licensing Policy of North Tyneside Council
- The guidance issued by the Secretary of State for Culture, Media and Sport on under Section 182 of the Licensing Act 2003.

#### **The Procedure of the Committee is as follows:-**

1. The Chair will open the hearing and will ask all persons present at the hearing to identify themselves. The Chair or Legal Adviser will then explain the procedure to be followed at the hearing.
2. The Committee will then consider any request made by a party under regulation 8(2) of the Licensing Act 2003 (Hearings) Regulations 2005 for permission for a person to attend as a witness on his/her behalf.
3. The Licensing Officer will present a report to the Committee outlining the application, any relevant representations and the relevant sections of the Council’s Statement of Licensing Policy and the statutory guidance.
4. Clarification on any aspect of the report may be sought by:
  - a) Members of the Committee
  - b) the Applicant
  - c) Responsible Authorities
  - d) Other Persons
  - e) Licence/Certificate Holder.
5. The Applicant will be invited to address the Committee about the application for review, indicating why they consider the issues they have raised to be relevant to one or more of the licensing objectives and sufficient to warrant a review of the premises licence/certificate.

6. If an Applicant has obtained prior permission to call a particular witness, then they may call that witness.
7. Relevant questions of the Applicant may be asked by:
  - a) Members of the Committee
  - b) Responsible Authorities
  - c) Other Persons
  - d) Licence/Certificate Holder.
8. Responsible Authorities will be invited to address the Committee, indicating why they consider the issues raised to be relevant to one or more of the licensing objectives and sufficient to support the application for a review of the premises licence/certificate. If a Responsible Authority has obtained prior permission to call a particular witness, then they may call that witness.
11. Relevant questions of the Responsible Authority may be asked by:
  - a) Members of the Committee
  - b) Applicant
  - c) Other Responsible Authorities
  - d) Other Persons
  - e) Licence/Certificate Holder.
12. Each of the Other Persons who have made representations will be invited to address the Committee about the application, indicating why they consider the issues raised to be relevant to one or more of the licensing objectives and sufficient to support the application for a review of the premises licence/certificate.
13. If any of the Other Persons have obtained prior permission to call a particular witness, then they may call that witness.

Note: In order to avoid repetition and to expedite proceedings at the hearing, objectors within the same group of Other Persons are encouraged to appoint an agreed spokesperson to address the Committee.

14. Relevant questions of the Other Person may be asked by:
  - a) Members of the Committee
  - b) Applicant
  - c) Responsible Authorities
  - d) Other Persons
  - e) Licence/Certificate Holder.

15. The Licence/Certificate Holder or their representative will be invited to address the Committee.
16. If the Licence/Certificate Holder has obtained prior permission to call a particular witness, then they may call that witness.
17. Relevant questions of the Licence/Certificate Holder may be asked by:
  - a) Members of the Committee
  - b) Applicant
  - c) Responsible Authorities
  - d) Other Persons
18. The Chair will invite each party to make a brief closing statement. Parties should ideally take no longer than 10 minutes to make their closing statement. Parties will be invited to sum up in the following order:
  - a) Applicant
  - b) Responsible Authorities
  - c) Other Persons
  - d) Licence/Certificate Holder.
20. The Chair will ask all parties if they are satisfied that they have said all they wish to.
21. The Committee will retire in private to consider the application and make its determination. The Legal Adviser will be present to ensure that all matters of law, evidence and procedure are adhered to appropriately but will not take part in the decision.
- 22.1 In considering any representations or a notice made by any party, the Committee may take into account documentary or other information produced by a party in support of their application, representations or notice (as the case may be) either before the hearing or, with the consent of all the other parties, at the hearing.
- 22.2 The Committee shall disregard any information given by a party or by any person to whom permission to appear at the hearing is given by the Committee, which is not relevant to:
  - (i) their application, representations or a notice (as the case may be) or, in the case of another person, the application, representations or notice of the party requesting their attendance; and
  - (ii) the promotion of the licensing objectives or, in relation to a hearing to consider a notice given by a chief officer of police, the prevention of crime and disorder licensing objective.

**NB** Parties are reminded that any documentary or other information or evidence they wish to produce in support of their application or representation must have been disclosed to all parties prior to the hearing taking place. **Late representations, documents or evidence will only be considered with the agreement of all parties present.**

23. The parties to be advised of the Committee's decision, including reasons for the decision and the decision will be followed up in writing in accordance with statutory requirements. The decision letter will include the reasons for the decision, and any conditions placed upon the licence and the licensing objective(s) they relate to. The notification of decision will include information on a party's right to appeal against the Committee's decision.

## **General Matters**

### **1. Expectations on parties**

(a) The Licensing Authority expects all parties to a hearing to endeavour to address any issues openly and to work towards an amicable resolution, if at all possible, prior to the hearing taking place.

(b) All parties will be expected to:

- (i) demonstrate which of the four licensing objectives are addressed in relation to each of the issues they wish to raise at the hearing;
- (ii) draw to the Committee's attention any relevant aspects of the National Guidance or local Statement of Licensing Policy which they also consider are particularly relevant to the Committee's consideration of the issues the party(ies) has/have raised.

### **2. Agreement that a hearing is unnecessary**

A Licensing Authority can dispense with holding a hearing if all persons concerned (Applicants and parties raising a representation) give notice to the Licensing Authority prior to the hearing date that they consider it unnecessary.

Where all such persons have given such notice, and the Licensing Authority agrees that a hearing is unnecessary, the Licensing Authority will give notice to the parties that the hearing has been dispensed with.

### **3. Failure of parties to attend**

The hearing may proceed in the absence of any party who has informed the Licensing Authority that they do not intend to attend or be represented at the hearing.

If a party fails to attend or be represented at a hearing without notifying the Licensing Authority, the Committee may adjourn the hearing to a specific date if it considers it to be in the public interest to do so, or alternatively may proceed with the hearing in the party's absence. In the interests of the other parties, costs and efficiency, hearings will generally proceed notwithstanding the absence of any party (including the Applicant).

Where it is decided to proceed in a party's absence, all notices and representations received from the absent party will be considered by the Committee.

If, in exceptional circumstances, a decision is made to adjourn a hearing, all parties will be advised of the date, time and venue to which the hearing has been adjourned.

**4. Questioning of parties**

The Licensing Authority will generally allow all parties to ask questions of another party present, but this decision will be taken on a case by case basis and in some exceptional circumstances (a reason will be given) questioning may be prohibited.

**5. Further clarification**

When addressing the Committee each party shall respond specifically to any points of which it received notice (with the Notice of Hearing) upon which the Committee was seeking clarification.

**6. Questioning by Legal Adviser**

The Legal Adviser to the Committee may ask questions on behalf of, or in addition to, the Committee Members themselves.

**7. Hearsay evidence**

Hearsay evidence will be admissible provided that it is relevant. The weight to be attributed to hearsay evidence will be a matter for the Committee.

**8. Persons behaving in a disruptive manner**

The Committee has the right to exclude any person disrupting the hearing, at their discretion. The Committee can refuse to allow that person to return or, alternatively, may permit him/her to return on such conditions as the Committee may decide. Any person required to leave the hearing may, before the end of the hearing, submit to the Committee in writing any information which they would have been entitled to give orally had they not been required to leave.

**9. No decision-making by Ward Members**

A Member of the Licensing Committee shall not be entitled to participate in any decision-making in relation to any licensing application concerning premises in the Ward for which he/she serves as Councillor.

### 1.0 Summary / Purpose of Report

#### 1.1 Licensing Sub-Committee

The Licensing Act 2003 provides that, where an application has been received in respect of the review of a premise licence, a hearing must be held to consider it. Sub-Committees have been established in accordance with provisions of the Act for the purpose of hearing such applications.

1.2 The Sub-Committee is asked to consider and determine an application from The Local Weights and Measures Authority for the review of a Premise Licence for Prudhoe Off Licence Store held by Mr Ghulam Nabi.

1.3 The applicant has been invited to attend the meeting to put forward their case in support of the review application. All persons making relevant representations in support of the applications have been invited to attend as well as the premise licence holder.

## 1.4 Representations from Responsible Authorities and Other Parties

The applicant for a review is required to forward copies of the application to Local Planning Authority, Environmental Health Authority, Health and Safety Enforcement Agency, Licensing Authority, Director of Public Health, Fire Authority, the Local Safeguarding Children Board and Home Office Immigration Department with a view to any of these Responsible Authorities making a supporting representation if deemed appropriate.

In addition the application has been advertised by the Licensing Authority at the premises, at the main offices of the Council and on the Council website as prescribed. Supporting representations have been made by The Chief Officer of Police, Director of Public Health and The Local Safeguarding Children Board. These are attached at **Appendix 5**.

## 1.5 Authority to make decisions

In relation to an application for the review of a premise licence the Licensing Sub-Committee can, under the Licensing Act 2003:

1. Modify the conditions on the licence
2. Exclude a licensable activity from the scope licence
3. Remove the Designated Premises Supervisor
4. Suspend the licence for a period of not more than three months
5. Revoke the licence

Once the Sub-Committee has reached a decision, the decision and reasons for the decisions must be given in accordance with the Licensing Act 2003 and the Licensing Act 2003 (Hearings) Regulations 2005.

## 2.0 Background

This report relates to an application by the Local Weights and Measures Authority for the review of a premise licence for Prudhoe Off Licence Store held by Mr Ghulam Nabi.

The application for review and supporting information are attached at **Appendix 1**, plan of the premises is attached at **Appendix 2** and a map of the area is attached at **Appendix 3**. The current premise licence is attached at **Appendix 4** and Supporting Representations at **Appendix 5**.

## **2.1 The Application for the Review of a Premise Licence under Section 51 of The Licensing Act 2003**

The Application for the review of the premise licence is made pursuant to Section 51 of the Licensing Act 2003 and the relevant Section of the Act dealing with the determination of such an Application is contained in Section 52 of the Act. The grounds for the review are the prevention of crime and disorder and protection of children from harm.

## **2.2** The current premise licence in respect of Prudhoe Off Licence Store allows the following:

### 1. To permit the premises to **Supply Alcohol** (off the premises)

- Monday to Saturday – 08.00 – 23.00
- Sunday 10.00 – 22.30

# Appendix AB1

## Prudhoe Off Licence

### Background

Prudhoe off licence is a small convenience store that sells alcohol, tobacco, confectionary and general groceries.

There are three people involved in the business Mr Ghulam Nabi and his two sons Ali and Khalid. The premises licence holder and designated premises supervisor is **Mr Ghulam Nabi**.

This review deals with the sale and possession of illicit tobacco from the premises which does not concern any of the licensable activities under the Licensing Act 2003, however it does concern one off the licensing objectives i.e. the prevention of crime and disorder. There have been three seizures of illicit tobacco by trading standards officers from this business. The table below is the intelligence that has been received by the Authority regarding the premises selling illicit tobacco. Illicit tobacco is tobacco that is either smuggled (non duty paid - contraband) or counterfeit.

### Intelligence

<b>Date</b>	<b>Information</b>
<b>06 /11/2015</b>	Intelligence from Northumbria Police premises is selling non tax paid and pouches of tobacco from under the counter
<b>21/08/2017</b>	Intelligence from Northumbria Police premises is selling illegal tobacco
<b>09/03/2018</b>	Anonymous complaint premises selling counterfeit tobacco
<b>14/11/2018</b>	Anonymous letter informing premises is selling illegal cigarettes and tobacco from under the counter

As a result of this information the following action has been taken

### First seizure

On 1<sup>st</sup> December 2015 as part of a local operation against the sale of illicit tobacco products, which was intelligence led, a number of premises were visited by the Authority's Trading Standards team. They were accompanied by Northumbria Police and a tobacco detection dog. One such premise was Prudhoe Off Licence 4-5 Prudhoe Street, North Shields, NE29 6QZ.

Within these premises officers discovered and detained quantities of illicit tobacco which were in a hidden compartment which contained two plastic boxes containing 60 x 50 grammes of Turners hand rolling tobacco and 1,960 Mayfair cigarettes.

The Turner hand rolling tobacco that was seized has no fiscal marks (UK non duty paid) and is smuggled tobacco. This has been confirmed by an officer from HMRC and is included in a statement at **Appendix AB2**

The Mayfair cigarettes were examined by a representative from Gallaher Limited, the trade mark holder for Mayfair cigarettes. He confirmed that the cigarettes were counterfeit and is included in a statement at **Appendix AB3**

The Mayfair cigarettes were also tested for **Reduced Ignition Propensity (RIP)** Since 2011 all cigarettes sold throughout the EU must conform to a new standard which requires cigarettes must self extinguish when left 'unpuffed'. The tests revealed that the cigarettes did not comply and were therefore 'unsafe'

Mr Ghulam Nabi (the premises licence holder) was interviewed under caution in relation to the tobacco found on the premises. Below is a summary of his account regarding the illicit tobacco. It is clear that Mr Nabi was aware that he was engaging in criminal activity:-

- In September 2015 two polish men visited the shop and then supplied and advised him where to hide the illegal tobacco.
- He bought them for cash and didn't get a receipt
- He buys the cigarettes for £25 per sleeve (200) and the hand rolling tobacco for £5.60 per packet and it was his intention to sell to members of the public
- He sells the cigarettes for £3.50 per packet and the hand rolling tobacco for £7.00 per packet
- Mr Nabi stated that genuine cigarettes sell for up to £10 per packet
- He claimed that this was his first time he has done this and will not do it again

The Trading Standards Officer's S.9 Statement regarding the investigation is included at **Appendix AB4**

On the 3<sup>rd</sup> June 2016 Mr Ghulam Nabi (the premises licence holder) pleaded guilty to eight charges relating to illicit tobacco. The offences related to:-

- The Trade Marks Act 1994 (counterfeit cigarettes),
- General Product safety Regulations 2005 (dangerous cigarettes relating to reduced ignition propensity),
- The Tobacco and Related Products Regulations 2016 (incorrectly labelled tobacco and cigarettes relating to warnings) and
- The Standardised Packaging of Tobacco Products Regulations 2015 (Requirement for all tobacco to be sold in plain packaging)

Mr Nabi was fined a total of £ 637 (including costs)

### **Second seizure**

On 3<sup>rd</sup> May 2018 as part of another local operation against the sale of illicit (counterfeit or smuggled) tobacco products, which was intelligence led, a number of premises including Prudhoe Off Licence were visited by the Authority's Trading Standards team. They were accompanied by Northumbria Police and a tobacco detection dog.

Within these premises officers discovered and detained quantities of illicit tobacco which were hidden under the counter in an old till and under a shelf that had been

screwed down that revealed a secret compartment. The tobacco that was discovered was 340 Richmond cigarettes, 16 x 50 grammes of Turner hand rolling tobacco and 1 x 50 grammes Amber hand rolling tobacco

The Turner hand rolling tobacco that was seized has no fiscal marks (UK non duty paid) and is smuggled tobacco. This has been confirmed by an officer from HMRC and is included in a statement at **Appendix AB2**

A statement from Neil Ferguson Imperial Tobacco Limited, the trade mark holder for Richmond cigarettes, included in the report at **Appendix AB5**, confirms the cigarettes are counterfeit.

The Richmond cigarettes were also tested for Reduced Ignition Propensity (RIP). The tests revealed that the cigarettes did not comply and were therefore 'unsafe'

At the time of the seizure Mr Ali Nabi stated that the business belonged to him. Mr Ali Nabi was interviewed under caution where he stated that he was the licensee and designated premises supervisor. He stated that the tobacco that was seized belonged to a 'good' friend and that he was only storing it for him as his friend didn't want his family knowing that he smoked. He denied having sold any of the tobacco.

The Trading Standards Officer's S.9 Statement is included at **Appendix AB6**

8 charges were laid against Mr Ali relating to illicit tobacco. The offences related to:- The Trade Marks Act 1994 (counterfeit cigarettes), General Product safety Regulations 2005 (dangerous cigarettes relating to reduced ignition propensity), The Tobacco and Related Products Regulations 2016 (incorrectly labelled tobacco and cigarettes relating to warnings) and the Standardised Packaging of Tobacco Products Regulations 2015 (Requirement for all tobacco to be sold in plain packaging)

Mr Ali Nabi pleaded guilty to the three Trade Marks offences concerning the Richmond Cigarettes, the main offence being "possession for supply" (s.92(1) Trade Marks Act 1994). The other five offences were withdrawn. Mr Ali Nabi was fined £860 (including costs) for the "possession to supply" offence, and No Separate Penalty for the other two.

It should be noted that Mr Ali Nabi is not the licensee and designated premises supervisor. This is Mr Ghulam Nabi

### **Third seizure**

On 14<sup>th</sup> February 2019 as part of another local operation against the sale of illicit (counterfeit or smuggled) tobacco products, which was intelligence led, a number of premises including Prudhoe Off Licence were visited by the Authority's Trading Standards team. They were accompanied by Northumbria Police and a tobacco detection dog.

Illicit tobacco was found in the jacket pocket that was being worn by Khalid Nabi and was seized, no other illicit tobacco was found in the premises or vehicles belonging to

the Nabi's. The tobacco discovered was 4 packets of Embassy Regal cigarettes and 2 pouches of Turner hand rolling tobacco. The

Mr Khalid Nabi stated that the cigarettes and tobacco were for his personal use and he had just bought it from a gentleman who he met in North Shields earlier that day, he didn't know his name and he paid £10 for each tobacco pouch and £7 for each cigarette packet.

The premises have CCTV fitted. Officers attempted to retrieve CCTV data but discovered that the CCTV was not recording

The Turner hand rolling tobacco that was seized has no fiscal marks (UK non duty paid) and is smuggled tobacco. This has been confirmed by an officer from HMRC and is included in a statement at **Appendix AB2**

A statement from Neil Ferguson Imperial Tobacco Limited, the trade mark holder for Embassy Regal, included in the report at **Appendix AB7**, confirms the cigarettes are counterfeit.

The Embassy Regal cigarettes were also tested for Reduced Ignition Propensity (RIP). The tests revealed that the cigarettes did not comply and were therefore 'unsafe'

A criminal investigation into this matter is ongoing.

On the 9/12/16 a sixteen year old volunteer was able to purchase alcohol during a test purchase exercise. As this was the first sale of alcohol made during a test purchase exercise at this premises the matter was dealt with by a warning letter and a request to voluntarily amend the conditions on the premises licence to include additional conditions regarding proof of age challenge policy. The letter is included with this report at **Appendix 8**



## Summary

Due to all of the above, as a responsible authority under the Licensing Act 2003, North Tyneside Council Trading Standards have real concerns about the premises being used for criminal purposes. The crime prevention objective is being undermined. In particular it is incredulous that even after two previous convictions for illicit tobacco offences the premises has continued to commit crime by possessing for supply illicit tobacco. Trading Standards have taken a stepped approach to these premises believing that the criminal activities would cease after the two prosecutions.

It is very important to stop the sales of illicit tobacco, as not only does it have serious consequences for health it also discourages smokers from quitting due to its low price. Price has been identified as the most effective barrier to smoking and this also makes it more attractive to children, making it even easier for them to get hooked on smoking.

It is also worth noting that contravention of s144 of the Licensing Act - 'Keeping of smuggled goods' is a criminal offence. Trading Standards did not charge on this offence.

Finally, I would to draw the Committees attention to the Home Office Revised Guidance issued under section 182 of the Licensing Act 2003 (April 2018) specifically paragraphs:-

### Reviews arising in connection with crime

#### **11.24**

A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises, money laundering by criminal gangs, the sale of contraband or stolen goods, the sale of firearms, or the sexual exploitation of children. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective

#### **11.27**

There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:

- for the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people.
- for the sale or storage of smuggled tobacco and alcohol.

#### **11.28**

(It is envisaged that licensing authorities, the police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence – even in the first instance – should be seriously considered.

It is considered appropriate that the Committee follow the Home Office Guidance at 11.28 specifically that the crime prevention objective is being undermined through the premises being used to further crimes and the correct decision in this case is that the premises licence should be revoked.

The Tobacco Products Duty Act 1979 Section 8C (As amended by the Finance Act 2000 Section 14) introduced regulations regarding the requirement for the appearance of fiscal mark. I am a Senior Trading Standards Officer employed by North Tyneside Council being based at The Silverlink North, Cobalt Business Park, North Tyneside, NE270BY. My duties include the enforcement of the Trade Marks Act 1994 (as amended), The Tobacco Products (Manufacture, Presentation and Sale) (Safety) Regulations 2002(as amended) and The Consumer Protection from Unfair Trading Regulations 2008(as amended).

On the 1<sup>st</sup> December 2015, as part of a local operation against the sale of illicit/counterfeit tobacco products, a number of premises were visited by Trading Standards, Northumbria Police and a dog handler from BWY Canine, one such premises was Prudhoe Off Licence 4-5 Prudhoe Street, North Shields, NE29 6QZ.

At approximately 11:25am I entered the premises and I introduced myself and asked the man behind the counter, who I now know to be Khalid Nabi, if I could to speak to the owner of the store, I was informed this was a Mr Ghulam Nabi who was upstairs. Mr Nabi then arrived and I showed him my warrant of authority and explained to him that myself as well as other officers and a sniffer dog intended to carry out a search of the premises for illicit/counterfeit tobacco products using powers contained under S93(2) of the Trade Marks Act 1994. I then explained the Notice of Powers and Rights document, copy produced as exhibit DRH/1a, and that he would be given a copy once we had completed our inspection. Another man then entered the store and said he was Mr Nabi's son, Ali Nabi. The store was closed off to customers and the dog handler proceeded to carry out a free search of the foodstore area of the shop looking for tobacco products, nothing was found. Mr Ghulam Nabi then asked if we wanted to search the upstairs flat I said if he consented to that then

we would, he agreed. The dog handler then moved to the rear of the premises and to the upstairs flat, they did not do a full search of the flat. The dog handler then returned to search the area behind the counter where the dog signalled the presence of tobacco under the counter. I asked Mr Ghulam Nabi and his sons if there was any tobacco under the counter and they said no. I took a photograph of the area, produced as exhibit DRH/2a. I then removed the sweets that were on the shelf at the bottom of the counter and lifted up the shelf to reveal a hidden compartment containing two plastic boxes containing Turners tobacco and packets of Mayfair cigarettes, photo produced as exhibit DRH/3a. I asked if there were anymore and Mr Nabi said no. I then lifted the next shelf along which revealed more cigarettes, photo produced as exhibit DRH/4a. All the items were removed and examined and as I believed all to be non UK duty paid or counterfeit these were seized. Mark Duffy bagged and sealed the items and while he was doing this I spoke to Mr Nabi and explained to him that we were seizing these goods as illicit, he was advised that he would be cautioned and interviewed at a later date where he would be given an opportunity to explain why the products were on the premises and in a secret storage area. I left Mr Ghulam Nabi a Code B notice of powers and rights and at approximately 11:55am we left the premises and I returned to the main North Tyneside Council offices at Cobalt Business Park, Silverlink. Mark Duffy then handed me the evidence bag R00678444 containing the tobacco and I put it in the evidence store. On the 11<sup>th</sup> December 2015 I removed the evidence bag R0678444 opened it, counted and took photos of the items. There were 60x 50g pouches of Turner tobacco, 200 Superking cigarettes and 1760 Mayfair cigarettes. I replaced them all back in the bag and sealed with seal NT00827. On the 14<sup>th</sup> December I removed seal NT00827 and took photographs of some of the items and returned all products to bag and resealed with NT000617. On 22<sup>nd</sup> December 2015 I hand delivered a letter to Mr Nabi, copy produced as exhibit DRH/5a, he opened and read the letter and we agreed that he would contact me after the 4<sup>th</sup> January to arrange a date for interview. I spoke to Mr Nabi on the 5<sup>th</sup> January and agreed an interview date of 15<sup>th</sup> January. On 14<sup>th</sup> January I removed seal NT000617 and took a sample of each type of product, 4 in total then resealed the bag with seal 3688129. The four samples were placed in evidence bag ME025667 produced as exhibit DRH/7a.

On 15<sup>th</sup> January together with Mark Duffy I interviewed Mr Nabi with his son Khalid Nabi also present, I produce a transcript of the interview as exhibit DRH/8a.

On the 29<sup>th</sup> February I opened the sample bag sealed with 3688129 and removed two packets of each type of cigarettes, for ignition propensity analysis. The bag was resealed

with seal NT00695 produced as exhibit DRH/6a. The samples were marked DRH/Mpale/RIP/1 sealed in evidence bag ME041848, DRH/MDark/RIP/2 sealed in ME041850 and DRH/Sking/RIP/3 sealed in ME041849. On the 1<sup>st</sup> March I took these to the test laboratory in Gateshead.

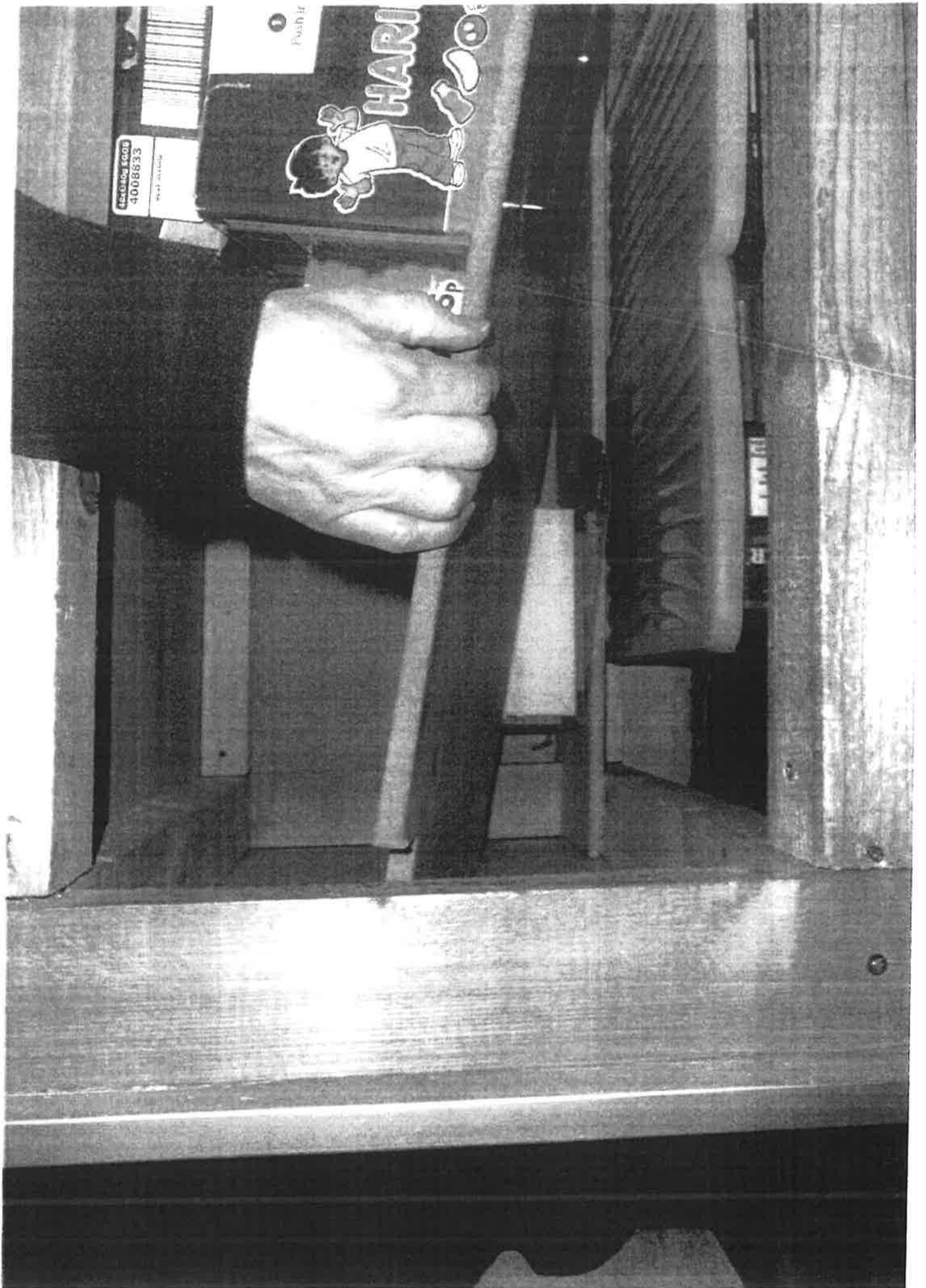

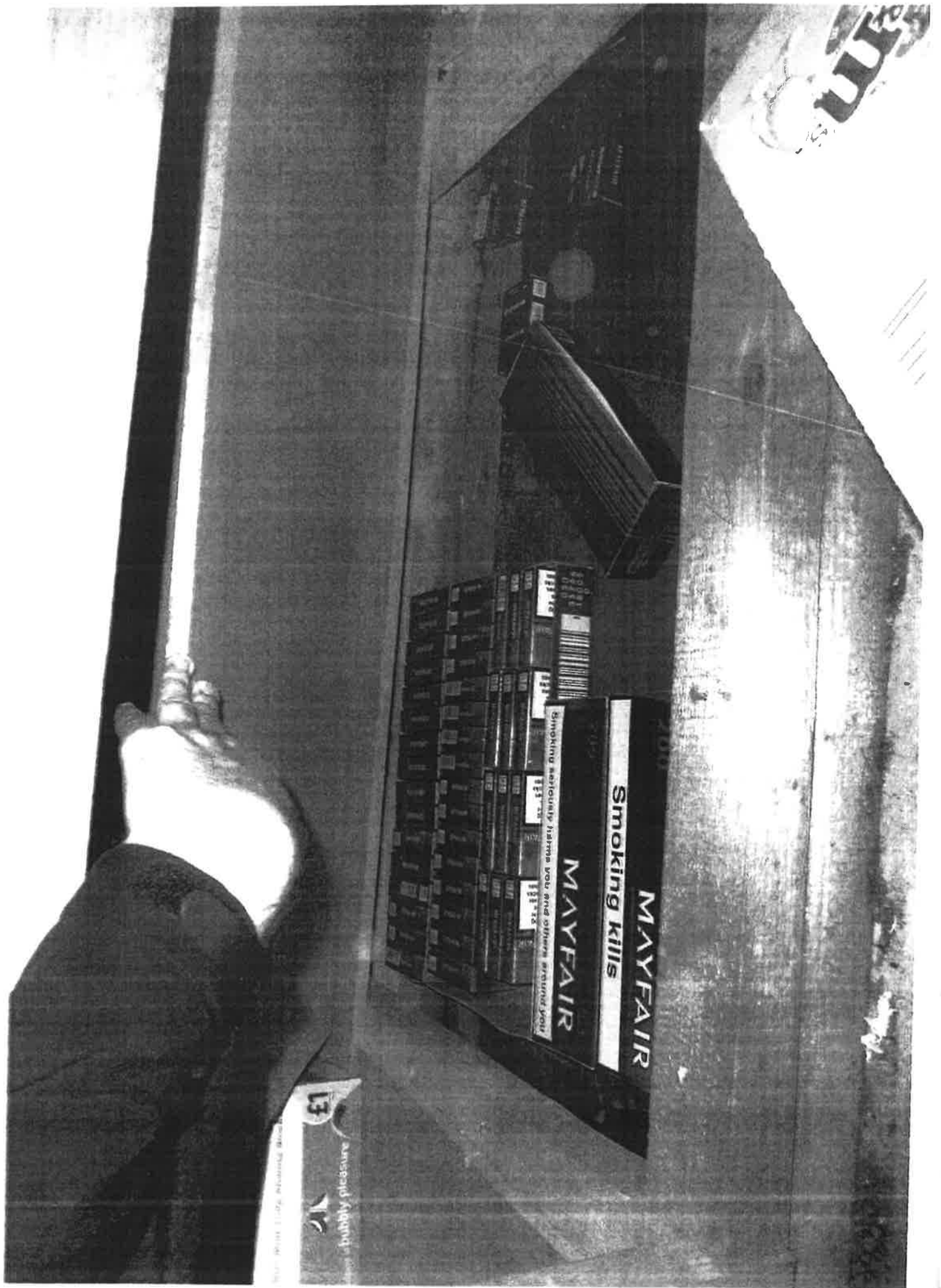

**Sealed evidence bag seal number P00083974 containing  
6 x 20 packets of branded Richmond King Size cigarettes.**

Having completed an examination of a selection of the packets of cigarettes I can now confirm that the print and materials used in the manufacture of the packets of cigarettes was not consistent with Imperial Tobacco Ltd specifications.

Consequently, I can state that the packets of cigarettes which I have examined were not made by Imperial Tobacco Ltd nor did Imperial Tobacco Ltd authorise their manufacture or sale.

I can confirm that Imperial Tobacco Ltd own the registered trademark for Richmond.



My duties include the enforcement of the Consumer Protection Act 1987, Tobacco and related Products Regulations 2016, Consumer Protection from Unfair Trading Regulations 2008 and the Trade Marks Act 1994.

On the 3rd May 2018, as part of a local operation against the sale of illicit/counterfeit tobacco products, a number of premises were visited by Trading Standards, Northumbria Police, HMRC and a dog handler from BWY Canine, one such premises was Prudhoe Off Licence 4/5 Prudhoe Street, North Shields.

At approximately 12:05pm I entered the premises with a policeman and an HMRC officer. I introduced myself to the man behind the counter, who I know to be Ali Nabi, I asked if he was the owner and he said yes. I showed him my warrant of authority and explained to him and his father Ghulam Nabi who was also present that myself as well as other officers from HMRC and a tobacco detection dog handler intended to carry out a search of the premises for illicit/counterfeit tobacco products using powers contained in the Consumer Rights Act 2015. I then explained the Notice of Powers and Rights document and that he would be

given a copy once we had completed our inspection. The store was closed off to customers and the dog handler proceeded to carry out a search of the shop and adjoining store rooms, looking for tobacco products.

I asked Mr Ali Nabi if they had any illegal cigarettes, he said no. The dog handler then found a number of illicit tobacco products, 5 packets of Richmond cigarettes and 5 packets of foreign labelled Turner tobacco in a spare till under the counter. The dog handler then asked Mr Nabi to open a locked compartment of the main till, which he did and that was found to contain illicit tobacco, 5 packets of Richmond cigarettes and 5 packets of foreign labelled Turner tobacco I handed these to Mark Duffy to place into an evidence bag, I produce a document showing photographs of the tills as exhibit DRH1p. The dog then indicated more tobacco by a shelf and on closer inspection it appeared to have a false storage area. I then explained to Mr Nabi that I was going to force open the shelf if he didn't open it, I then noticed the shelf was held down with screws, a policemen brought me a screwdriver that was in the shop and I removed two screws, lifted the shelf that uncovered a compartment containing more illicit tobacco, 6 packets of foreign labelled Turner tobacco, 7 packets of Richmond cigarettes and 1 packet of Amber tobacco. I handed these to Mark Duffy to put into an evidence bag. I took a photos of the hidden compartment produced as exhibit DRH2p.

When we were finished I gave Mr Ali Nabi a copy of the Notice of Powers and Rights and Summary of Powers and Rights copy produced as exhibit DRH1a and a Notice of Seizure copy produced as exhibit DRH2a, that detailed the tobacco seized. We then left the premises at approximately 12:40.

Back in the office Mark Duffy handed me three evidence bags containing the seized items numbered P00083928, P083974 and ME041860.

On the 14th May I took a sample of three packets of Richmond cigarettes to the laboratory for fire propensity testing.

On the 23<sup>rd</sup> May I visited Prudhoe Off Licence to confirm details of ownership and Ali Nabi said he was sole owner and showed me cheque book that Prudhoe Off Licence printed in it, the following day I hand delivered a letter inviting Mr Nabi for interview, copy produced as exhibit DRH3a. I took photographs of the seized items as shown to Mr Nabi in interview and produce these as exhibits DRH3p, DRH4p and DRH5p.

- *it was in the shop as they had no other place to put it*
- *at the time of inspection he said he didn't have any on the premises as the tobacco and cigarettes were not his, "it was just heat of the moment, I didn't know what to say"*
- *he knew that they were illegal to sell*
- *Mr Dalton brought the tobacco into the shop about 29<sup>th</sup> April*
- *He was aware that they had similar issues in 2015*
- *Only Ali and Khalid Nabi knew that the cigarettes and tobacco were there (strange as his dad kept his Amber leaf there as well)*
- *Mr Dalton bought the cigarettes and tobacco from 'Alan' at the Parks Gym*

On the 12th June two officers from HMRC examined the seized goods and confirmed they were non duty paid.

**Warning Letter**  
**The Licensing Act 2013**  
**Sale of Alcohol to a Minor on 9<sup>th</sup> December 2016**

I write further to my discussion with you on the 12<sup>th</sup> January 2017 regarding the above incident.

On Friday 9<sup>th</sup> December 2017 as part of a joint test purchasing exercise by officers from this Authority and Northumbria Police a 16 year old male volunteer visited your store and attempted to buy alcohol. The volunteer approached the till and proceeded to purchase 4 cans of Foster lager. He was not asked for any ID or asked his age.

As you are aware it a criminal offence under the Licensing Act 2003 to sell alcohol to a person under 18 years of age. At the time Mr Ghulam Nabi, who sold the alcohol received a £90 fixed penalty notice issued by a Police Officer for contravention of section 146 of the 2003 Act.

On the 12<sup>th</sup> January 2017, I discussed with you what procedures you have in place to help prevent sales of age restricted products to minors. During our discussion you were not able to produce a refusals book/log detailing challenges made to person appearing to be under 18 attempting to purchase alcohol, You did inform me that you operate a challenge 25 policy. You further informed me that you do not keep staff training records.

The Licensing Act 2003 provides a defence if a sale to a person under 18 occurs, if you can show you took all reasonable precautions, and exercised all due diligence to avoid committing an offence. While ultimately what steps are necessary to satisfy this defence would be up to a court of law to decide I would advise you to consider adopting the following steps: -

- Remind your staff and family members who work in the shop of the law relating to the sale of age restricted products such as alcohol. It would be advisable for each individual member to be given their own personal training record. Such as the one that contained the Age Aware pack I gave to you. This should include a signed statement by them that they have received advice and training from you regarding the sale of age restricted products.
- Members of staff should be advised that they, themselves, may be personally liable if they sell to young persons in breach of the legal requirements. If there is any doubt as to the age of a purchaser they should ask the prospective purchaser for suitable photographic identification, such as a passport, driving licence or a Proof of Age Standards Scheme (PASS) accredited proof of age card such as Citizenscard. If the person cannot provide satisfactory identification then the sale should be refused. Do not merely ask a person for their date of birth.
- You should hold regular refresher staff training sessions.
- You should maintain a refusals book/log for all age restricted products. Make sure all staff and anyone else who serves in the store record all refusals in this book. The refusals book should also be inspected and signed-off by you on a regular basis to ensure staff are following procedures. The refusals book should be kept close to the till.
- Operate a Challenge 25 policy. This means asking for ID from anyone who appears to be under 25 years old. This can help minimise the risk of making an underage sale and can assist any staff who are faced with making judgements about a purchaser's age. You informed me you intend to operate such a policy in the future.
- Display challenge 25 posters around your premises.

Further guidance on the law relating to age restricted products is contained in the Age Aware guidance pack which was supplied to you on the 15 April 2014. I have also included another Age aware guidance pack with this letter.

After due consideration of the full circumstances, it has been decided on this occasion to ask you to vary your premise licence to include the attached four licence conditions using the minor variation of premise licence form which is enclosed with this letter. Failure to do this may result in a formal review of the premises licence by ourselves or Northumbria Police which will result in a formal hearing before the Licensing Committee.

You are warned that should a similar incident occur in the future we may reach a different conclusion and commence criminal proceedings against the seller, licensee and/or any persons who may be vicariously liable.

It is my duty to draw your attention to the relevant provisions of the Licensing Act 2003, as set out in the enclosed Memorandum.

As discussed one of the methods used by Trading Standards to check whether or not sellers of age restricted products are complying with the law is to use child volunteers to visit shops to attempt to purchase such products. As such your store together with other stores which sell age restrictive products will be visited in the future.

## MEMORANDUM

### Licensing Act 2003

#### Section 146 Sale of Alcohol to Children

- (1) A person commits an offence if he sells alcohol to an individual aged under 18.
- (2) A club commits an offence if alcohol is supplied by it or on its behalf-
  - (a) to, or to the order of, a member of the club who is aged under 18, or
  - (b) to the order of a member of the club, to an individual who is aged under 18.
- (3) A person commits an offence if he supplies alcohol on behalf of a club-
  - (a) to, or to the order of, a member of the club who is aged under 18, or
  - (b) to the order of a member of the club, to an individual who is aged under 18.
- (4) Where a person is charged with an offence under this section by reason of his own conduct it is a defence that-
  - (a) he believed that the individual was aged 18 or over, and
  - (b) either-
    - (i) he had taken all reasonable steps to establish the individual's age, or
    - (ii) nobody could reasonably have suspected from the individual's appearance that he was aged under 18.
- (5) For the purposes of subsection (4), a person is treated as having taken all reasonable steps to establish an individual's age if-
  - (a) he asked the individual for evidence of his age, and
  - (b) the evidence would have convinced a reasonable person.
- (6) Where a person ("the accused") is charged with an offence under this section by reason of the act or default of some other person, it is a defence that the accused exercised all due diligence to avoid committing it.
- (7) A person guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 5 (£5,000) on the standard scale.

## **Section 153 Prohibition of unsupervised sales by children**

(1) A responsible person commits an offence if on any relevant premises he knowingly allows an individual aged under 18 to make on the premises-

- (a) any sale of alcohol, or
- (b) any supply of alcohol by or on behalf of a club to or to the order of a member of the club,

unless the sale or supply has been specifically approved by that or another responsible person.

(2) But subsection (1) does not apply where-

- (a) the alcohol is sold or supplied for consumption with a table meal,
- (b) it is sold or supplied in premises which are being used for the service of table meals (or in a part of any premises which is being so used), and
- (c) the premises are (or the part is) not used for the sale or supply of alcohol otherwise than to persons having table meals there and for consumption by such a person as an ancillary to his meal.

(3) A person guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 1 (£200) on the standard scale.

(4) In this section "responsible person" means-

- (a) in relation to licensed premises-
  - (i) the holder of a premises licence in respect of the premises,
  - (ii) the designated premises supervisor (if any) under such a licence, or
  - (iii) any individual aged 18 or over who is authorised for the purposes of this section by such a holder or supervisor,
- (b) in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables him to prevent the supply in question, and
- (c) in relation to premises which may be used for a permitted temporary activity by virtue of Part 5-
  - (i) the premises user, or
  - (ii) any individual aged 18 or over who is authorised for the purposes of this section by the premises user.

## Recommended Licence Conditions

1. All members of staff at the premises shall seek "credible photographic proof of age evidence" from any person who appears to be under the age of 25 years and who is seeking to purchase or obtain alcohol from the premises. Such credible evidence shall include either be a passport, photographic driving licence or proof of age card carrying a "pass "logo.
2. A book detailing all challenges of customers as to their age and the outcome of those challenges will be maintained and kept at the premises at all times and will be made available for inspection on request and removal if necessary by the Council's licensing officers or Police representatives.
3. The book detailing challenges as to the age of customers will be inspected by any Designated Premise Supervisor or manager employed at the premises on a weekly basis and a signed declaration made in the book each week by such person declaring that the book has been duly inspected by them.
4. There will be notices prominently displayed at the premises, particularly at points of sale and where alcohol is displayed for sale, stating that a challenge 25 policy operates at the premises and that appropriate photographic identification will be required to be produced on request.

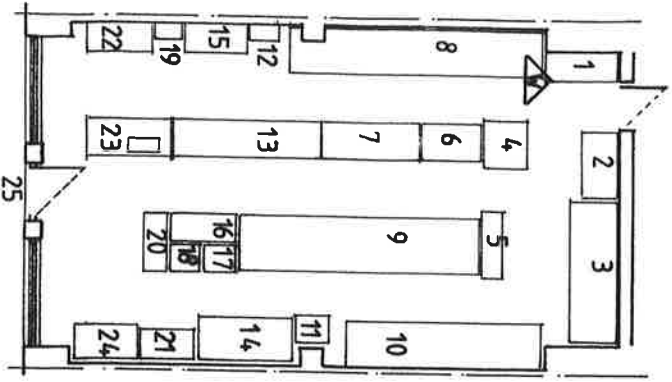

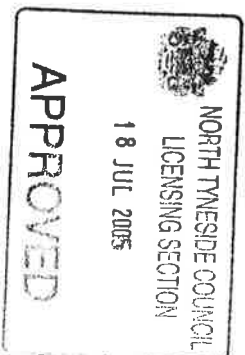

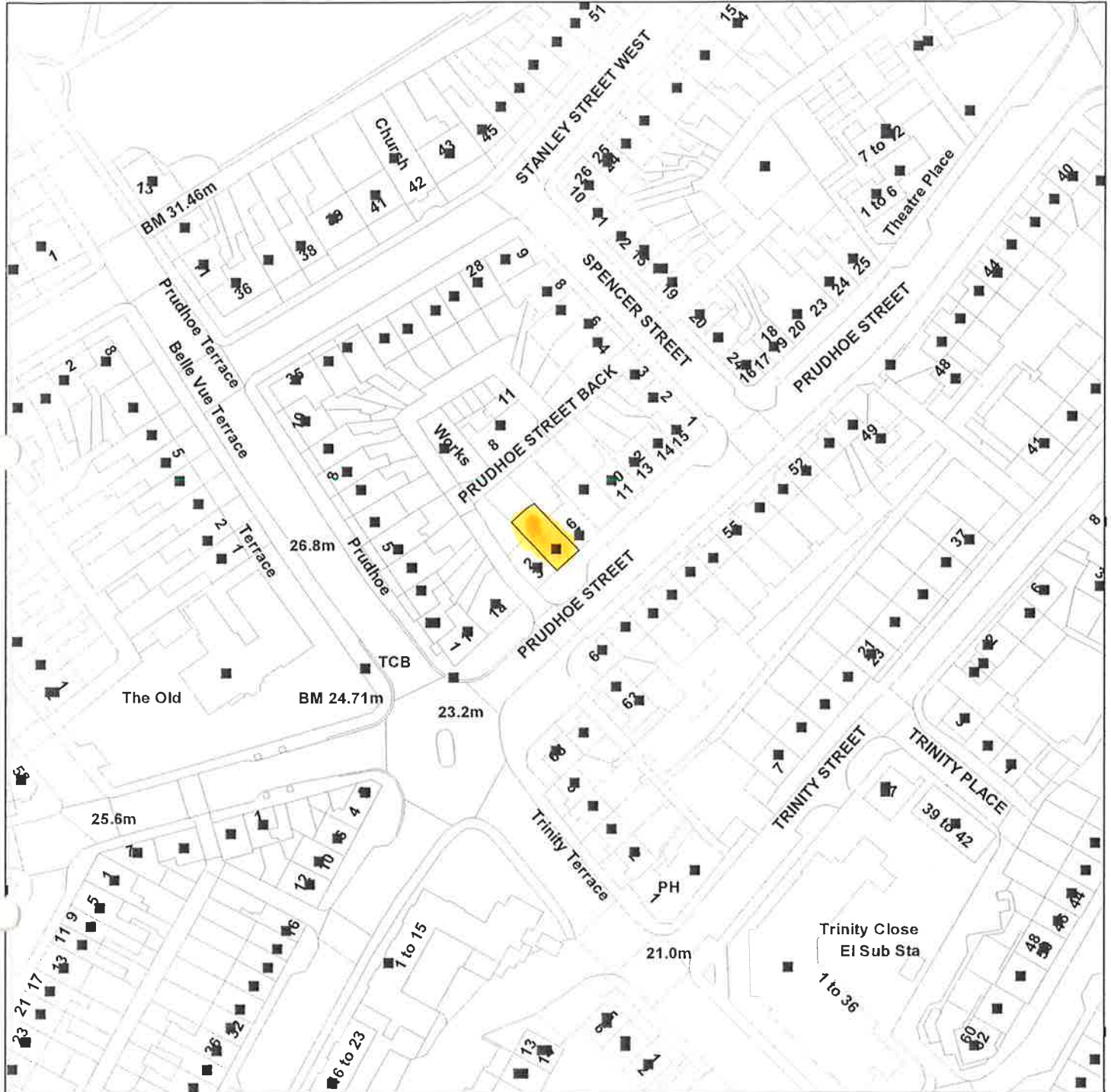

**Annex 1 - Mandatory conditions**

- 1. No supply of alcohol may be made under this premises licence:-**
- (a) at a time when there is no designated premises supervisor in respect of the premises licence or**
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.**
- 2. Every supply of alcohol under this premises licence must be made or authorised by a person who holds a personal licence.**

**The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 - with effect from 1st October 2010 as amended on 1st October 2014**

- 1.(1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.**
- (2) The designated premises supervisor in relation to the premise licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.**
- (3)The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -**
- (a) a holographic mark, or**
  - (b) an ultraviolet feature.**

**The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014 with effect from 28th May 2014**

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.**
- 2. For the purposes of the condition set out in paragraph 1—**

"relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

"valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

**Annex 2 - Conditions consistent with the operating schedule**

- 1. This licence is granted subject to conditions which reproduce the effect of any restrictions imposed on the use of the premises for the existing licensable activity by virtue of schedule 8, Paragraph 6(8) and 18(5) of the Licensing Act 2003. The restrictions are contained in the following Acts: the Licensing Act 1964, the Children and Young Persons Act 1963, the Cinematograph (Safety) Regulations 1955 and the Sporting Events (Control of Alcohol Etc) Act 1985.**
- 2. All members of staff at the premises shall seek "credible photographic proof of age evidence" from any person who appears to be under the age of 25 years of age and who is seeking to purchase or obtain alcohol from the premises. Such credible evidence shall either be a passport, photographic driving licence or proof of age card carrying a "pass" logo.**
- 3. A book detailing all challenges of customers as to their age and the outcome of those challenges will be maintained and kept at the premises at all times and will be made available for inspection on request and removal if necessary by the Council's Licensing Officers or Police representatives.**
- 4. The book detailing challenges as to the age of customers will be inspected by any Designated Premise Supervisor or manager employed at the premises on a weekly basis and a signed declaration made in the book each week by such person declaring that the book has been duly inspected by them.**
- 5. There will be notices prominently displayed at the premises, particularly at points of sale and where alcohol is displayed for sale, stating that a challenge 25 policy operates at the premises and that appropriate photographic identification will be required to be produced on request.**

Northumbria Police wish to support the application from Local weights and Measures Authority, North Tyneside Trading Standards, for a review of the above named premises licence on the grounds of Crime and Disorder and Protection of Children from Harm.

The premise is situated on Prudhoe Street, near to the roundabout of the junction of Howdon Road and Waterville Road. It is within easy reach of North Shields Town centre and Public houses and shops.

On 14 January 2014, Mr Kirkpatrick Licensing Officer for the Police and Mr Hedley from North Tyneside trading Standards visited this shop; there was a complaint about Mr Ghulam Nabi selling alcohol via proxy sale to children. There were no CCTV cameras outside to monitor this. An inspection of the refusals register was conducted and found that the register had not been utilised in several months. Suitable advice was given to Mr G Nabi about keeping the document up to date.

In October 2014 the Police had received, through community intelligence, complaints about this shop selling cigarettes/tobacco to anybody from under the counter; it was further stated that the cigarettes and tobacco were counterfeit.

On 02 April 2015 an anonymous female called the Police; the person informed the Police; " my 13 year old friend can buy cigarettes at Prudhoe off licence and my 17 year old other friend can get alcohol" This was a third party report but it was passed to Mr Kirkpatrick to action.

On 09 December 2016 a test purchase was conducted at Prudhoe off licence as well as other premises in North Shields; Mr Ghulam Nabi sold alcohol to a child and a fixed penalty was issued and has been paid.

May I request the committee to have regard to revised guidance issued under section 182 of the Licensing Act 2003 (April 2018), Section 11.26.

Where the licensing Authority is conducting a review on the grounds that the premise has been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective.

May I request the committee to have regard to revised guidance issued under section 182 of the Licensing Act 2003 (April 2018), Section 11.27.

There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:

- For the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and the propensity for crime of young people:
- For the sale or storage of smuggled tobacco and alcohol.

May I request the committee to have regard to revised guidance issued under section 182 of the Licensing Act 2003 (April 2018), Section 11.28.

It is envisaged that licensing authorities, the Police, the Home Office (Immigration Enforcement) and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the Licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that, revocation on the licence-even in the first instance-should be seriously considered.

In August 2017 the police received through community intelligence that Prudhoe off licence was selling counterfeit tobacco/cigarettes. This was passed on to Trading Standards in North Tyneside council.

From December 2015 to date, The local Weights and Measures of North Tyneside council, assisted by Northumbria Police, have visited Prudhoe off licence in North Shields eight times; The operations have been an intelligence lead, partnership approach, reacting to the concerns of the community of North Shields.

Four of these have resulted in the seizure of illicit tobacco products. The owner and his son have admitted to the criminal possession of these items. One of the visits resulted in a sale of alcohol to a child by the DPS, who is also the Premises Licence Holder.

Northumbria police have lost confidence in the management of Prudhoe off licence in North Shields. The consistent poor management of the premises is of serious concern.

Due to the serious nature of this review, the selling of alcohol to a child, the consistent disregard for persistently storing and selling illegal/counterfeit tobacco and cigarettes Northumbria Police request the licensing committee to consider revocation of the premises licence, even in the first instance.

**Review of Premises Licence Prudhoe Off licence, 4-5 Prudhoe Street, North Shields**

We respectfully request that the licensing committee revoke the licence for the above premises in order to safeguard children and prevent crime.

We are extremely concerned about the wealth of evidence supplied by Trading Standards and the Police which demonstrates that Mr Ghulam Nabi as the licensee and designated premises supervisor does not take his responsibility seriously evidenced by both himself and his two sons who are involved with the business, having engaged in criminal activity on repeated occasions.

We do not believe that the premises licence holder up holds the licensing objectives and he has failed to protect children from harm by engaging in criminal behaviour.

While the failed test purchase for alcohol was back in 2016 and there have been no further failed test purchases, the repeated sales of illicit tobacco are extremely concerning. While fewer people than ever are now smoking, illegal cigarettes are often responsible for getting children initiated in to smoking as they can buy it at pocket money prices from people who don't care who they sell to. The figures, from the most recent North East Illegal Tobacco Survey identified that 55% of children aged 14 and 15 in the North East who smoke, reported buying illegal tobacco from sources from small independent shops and "tab houses". The sale of illegal tobacco is a criminal activity that supports a trade that encourages children to become hooked on cigarettes at younger ages and promotes dangerous products. Counterfeit tobacco has also been found to contain arsenic, rat droppings and far more tar and carbon monoxide than legal products.

It is clear that in order to protect children from harm and prevent further criminal activity that this premises licence should be revoked.
