Regarding the minor variation for the above property can you advise why I am not able to comment on this on the public access portal.

The existing planning consent does not allow opening after 9pm so I would like to object to any application to open and serve alcohol either onsite or off sales after this time. If the premises are allowed to serve alcohol after 9pm it would cause noise and disturbance to neighbours. The licensee would also be in breach of the planning conditions which they have done since this property was redeveloped until closing earlier this year.

Extract from planning conditions

The premises shall not be open to the public outside of the hours of 08:00 - 21:00 hours Monday to Saturday and 08:30 - 21:00 hours Sunday and Bank Holidays.

Reason: To safeguard the occupiers of adjacent properties from undue noise or other associated disturbance having regard to policy DM5.19 of the North Tyneside Local Plan (2017).

Can I add the following points

It would like to object to the proposed variation to the licensing conditions. I would also ask that if the variation applied to is be agreed then additional conditions should be applied to mitigate the increase in operational hours.

Additional restrictions on using the outdoor area after 9pm and for all doors and windows to be closed to stop noise disturbance. I would also like restrictions to be attached so that no deliveries/collections can be made between 6pm and 7:30am and no deliveries or collections on Sundays or Bank Holidays.

The reason for additional conditions is that I have on a number of occasion had to complain to the staff regarding collections and deliveries on bank holidays which creates noise and disturbance to myself and other residents. The only access is via the lane at the rear to my property and there is a constant stream of HGV vehicles making unsafe manoeuvres to back into the lane. Our car was badly damaged by a delivery vehicle and our neighbours wall has been knocked down by a wagon. Since the cafe re-opened the lane has been congested with parked cars belonging to staff and customers. Early morning collections by refuse wagons has increased in frequency which disturbs our sleep

I wish to object to the request for a change in layout to add the external area to the licence, and to modify the licencing drinking hours to allow drinking until 22:00 (22:30 on a Saturday), for Little Lobo, (formerly Cullercoats Coffee), 1-5 Countess Avenue, Whitley Bay NE26 3PN.

This will increase noise - and clatter clearing up - where there are small children living close by, plus possible rowdy behaviour of people in the street. There is already a bar adjacent to that premises, and others nearby. Already there is anti-social behaviour from people making their way home in a lively manner. One recent example is Halloween, when someone was amused by stealing a neighbour's child's large- and heavy - pumpkin, late at night, then flinging it at my window. Luckily, though a distressingly loud thump, it didn't break the window. but did actually break a pot and damage plants. You can imagine this was particularly distressing to me,
