Objection to Premises Licence – Scott and Wilson, 1 Trevor Tce., North Shields

It is with frustration and a degree of exhaustion that we find ourselves having to yet again make representation about the licensing hours at the Scott and Wilson bistro (1 Trevor Tce, North Shields).

You may recall we were the original objectors when the bistro first opened and our concerns were rejected by the applicant when the original licence was granted.

We understand however this time that other residents/businesses will also be expressing concerns about this application.

We are aware of the four criteria under which an alcohol licence is considered:

- a) prevention of crime and disorder
- b) public safety
- c) prevention of public nuisance
- d) protection of children from harm

In relation to this application we certainly think criteria b, c and d should be closely examined.

We are also aware that the applicant has to make a **retrospective** planning application for the material changes made to the bistro in relation to outside seating areas and there will be an opportunity at this point to address some of the main issues not covered by the licensing authority.

However, while the licensing committee does not have authority in relation to the planning application we believe the new outside seating areas have potential to impact on licensing criteria b, c and d.

b) **Public safety** – as the applicant has added seating around all sides of the bistro and on the grassed area this will make access difficult for the public so close to a busy main road especially with prams, wheelchairs and people who are visually impaired (e.g. residents of Peary House on Preston Road) who regularly use this route.

If the applicant is given permission to sell alcohol from 10 am to 11pm this has potential to impact on the public at any time of the day.

While we can't envisage why anyone would want to sit so close to traffic lights with all that brings – noise and pollution – no-one can predict what may happen here should there be excess alcohol consumption.

The fact that people might have to walk between two sets of people eating/drinking (grassed area and side of bistro) is also potentially an issue.

While The Gunner pub opposite has outside seating areas at least these are within the curtilage of the building/land and don't impose on the public walkway.

c) **prevention of public nuisance** – we know the closest residents to the bistro (including ourselves) are unhappy about the potential increase in noise – particularly in the evening – which has already proved an issue. As more drink and food is going to be served outside then there is the likelihood of the main door being left open adding to the potential for more noise.

We were very curious to note on the application that the applicant ticked that there will be **no** live or recorded music? However just a quick look at their Facebook page and there have been posts about a number of live music sessions (e.g.Feb 29 and March 17 (St Patricks Day).

Were occasional public entertainment licences applied for on these occasions?

The Facebook page also talks of plans for other event nights (posted prior to lockdown) – so if these are to become more regular will the applicant have to apply for a full public entertainment licence?

On 5th July the venue's Facebook page had *Happy 5th July AKA #biggesthangover day* – we hope this is not symptomatic of an irresponsible approach to excessive drinking from a supposedly responsible management?

They are also advertising an **all day** #Happy Hour for cocktails – shouldn't that be changed then to #Happy Day?

d) **protection of children from harm** – there is even more potential for children passing drinkers at the bistro than previously due to the significant increase in the outside seating areas and the longer serving hours. If a child is taken into a pub with a parent's knowledge that's fine but outside seating very close to a shop frequented by unaccompanied young people is not similarly controlled.

We also understand on Sat 4 July there were young children in the outside seating area until 10.30pm?

Off sales

We are surprised the application also requests off sales permission.

We were informed last time that over-supply/demand of alcohol cannot be an issue for the committee but it seems totally excessive when the bistro is sandwiched between a dedicated wine shop and the One Stop shop - both of which sell off sales alcohol.

Finally we were wondering why all of the applications (both planning and licensing) have all been applied for incrementally and retrospectively?

The applicant appears to have been allowed to introduce the new hours (advertised on Facebook) and add more outside seating without permission in advance.

Excuse my cynicism but with this approach there is little doubt there is a better chance of them being approved e.g. what may appear to be 'temporary' outside seating to address the Covid19 regulations – has a chance of becoming permanent thus expanding the capacity of the venue with potential to impact on criteria b) c) and d).

The lack of attempts at more transparent public consultation is also disappointing. The applicant was invited to a meeting with us mediated by the Council when we objected originally but never responded so we gave up and ourselves and other local residents have had to dig around to find this application and I have had to be proactive in contacting the planning department to discover they have not had preapproval for the outside seating.

What started as a small café/bistro has suddenly transformed into a significant 13/7 operation.

In the twenty years we have lived here there have been applications for tattoo parlours, betting shops, alcohol licence extensions and now another seven day a week alcohol provider – is it any wonder residents object? We have had our unfair share of this kind of premises licence application.

We ask that the Committee members consider the concerns raised by us and other residents when determining the application.

I am s, Trevor Terrace. This mail is regarding Scott & Wilson which is next to my premises. I have seen a notice application for premises licence serving alcohol outside and inside(upstairs) for Scott & Wilson. I spoke to the person who runs the business this morning who told me he's got permission to put benches on the grass patio in-front of my shop and has extended up-to the fortune city. He told me he is putting benches in-front of my shop pavement i.e. public access way.

- 1. I am objecting for the licence to serve alcohol on the grass patio because it's obstructing my business, people sitting in-front of my premises and direct visible infront of my premises and also creates big noise and people will be shouting when they are drunk. This will stop people entering into my shop. Some responsible people feel shy to come into my shop because others are sitting in-front of my premises and are scared to come into my shop. Therefore, I will lose trade.
- 2. I am objecting for the licence to serve alcohol on the pavement in front of shops because if you permit, there isn't a way for the general public to pass and no way for passing trade customers as well. I will lose trade in this situation as well. If he occupies the whole pathway and other shops will lose trading because of the lack of passing trade.
- 3. I am objecting for the licence to serve alcohol upstairs premises as well because in the weekends they play band and music. This will cause big disturbance and loud vibrations as well. Moreover, it will distract other businesses as well.
- 4. In Trevor terrace, there are 1-7 residential properties upstairs, if you permit licence to them, the council is breaking their privacy because they are not getting a chance to sit on the grass patio because many people and kids are scared to sit over there. This is a big problem for residential families, specifically, when kids & youngsters are studying for their careers.
- 5. When school children are crossing the path, they will be distracted and the benches on the pavement will block them, the whole place is occupied by the people. It's not a good environment for students to travel.
- So, in this situation, I strongly object permitting the licence to the Scott & Wilson for upstairs and outside. So, I hope you consider what I have said and rethink permitting the licence. I would like it if you could fix an appointment and I could personally talk to you about this situation.

- 1. Scott and Wilson, , I have a problem with the level of noise that I can hear. Even If they are having subtle conversations, I can still hear them. Especially, in the evening, when they are drunk, this causes a lot of shouting and doesn't create a good environment. If you permit license for upstairs and outside green patio, this creates more noise and trouble than it was before. In this situation, it's very distracting for me to run the business as it's uncomfortable for me to serve the customers.
- 2. How can the council give permission to serve alcohol in front of another premises? The green patio doesn't belong to Scott and Wilson, it's a public property, the green patio is not within their premises. So, is this fair?

 Here are a couple of pictures:




It will be very uncomfortable for people passing by to see people drinking and also for customers to enter my shop. It's not practical.





3. It is very impractical to have benches in front of Scott and Wilson shutters and on the grass patio. It will be very awkward for the public to pass by as there is limited space, the front of Scott and Wilson will be entirely blocked, letting no people to pass by.



There will also be benches on the green patio.

4. Traffic is also a big issue. Pedestrians will be at risk when people are reversing cars on the footpath. Due to deliveries of Fortune City, there is increased traffic, therefore this will increase accidents, especially when there is no dedicated parking area.

We have taken time to outline some extra points, hope you consider my concerns and reason for our representation when making your decision.

Today, I saw the application on the shutters of Scott and Wilson and saw the green area which has been fenced off. I strongly disapprove of it for the following reasons:

- 1) I have two children. A high school student who is studying and doing her schoolwork, and a primary school student. There is a high possibility that the customers of Scott and Wilson will get drunk and start misbehaving such as shouting. As we live nearby Scott and Wilson, this creates a real disturbance to my daughter who is studying. It is possible to hear even quiet conversations. She would not be able to focus due to the loud noise and music. Secondly, my son who usually visits the corner shop to buy snacks, would feel insecure and scared to pass by. He would need to be assisted by an adult. There will be a very loud atmosphere.
- Importantly, there is usually a lot of traffic as some of the lanes are used for parking.
 This could create accidents and put residents at harm when reversing the cars. The
 car could cross the pathways.
- 3) It is very impractical to serve alcohol outside in front and behind the grass area. They are also placing benches on the footpath, which doesn't enable people to walk freely on the footpath, the benches act as a blockade. Is this safe for children? I have never seen alcohol being served directly opposite the traffic lights and main road. Is this safe? They will be serving alcohol from 10:00 to 23:00. This will incite bad behaviour and create noise for those who live in nearby residential properties. This is very disturbing for the neighbourhood; they could also urinate in the back lanes of our houses.
- 4) Another key point that I would like to raise, considering what is happening at the moment, Covid 19. It will be very difficult to maintain social distancing as the area will become very congested. It won't be spacious at all and it will difficult for young children specially to maintain social distancing. To maintain social distancing, it is said that there is permission to increase the venue upstairs. However, I don't think this is practical as this just encourage more people to come, making it again more difficult to socially distance.
- 5) There are a couple of examples of accidents near the grass patio. There were around 2 accidents since the last 3 years. Both included cars driving over the pathway which is near the grass patio. This is a clear example that it is not safe for the public to be near the traffic signals. The main issue here is safety.

I hope you consider these points that I have mentioned above and reconsider your decision.

Representation against the award of a Premises License of 'On and Off Sales' of alcohol Monday – Sunday 10am – 11pm to Scott & Wilson, 1 Trevor Terrace, North Shields, NE30 2DG

Having been made aware of the above application, we the Shields, would like to formally raise a Representation against this for the following reasons;

Safety & Traffic

1. Covid 19.

Scott & Wilson is a small venue with limited space outside the venue for seating to overcome the challenges and maintain social distancing the proposal is to increase space inside the venue and to add seating on the footpath and on the grass area outside discussed later in this document and shown in picture b.

While this is understandable it is inappropriate in that it increases the number of people on the footpath outside and blocks path making it more difficult to maintain social distancing. It is important to note the One Stop is used by local residence and many customers are elderly, have disabilities or have small children and are as such vulnerable. It is unreasonable and impractical to expect them to social distancing and maintain their safety around customer of Scott & Wilson.

Traffic poses significant issues as the back lane between 9 and 11 Trevor Terrace and the above is used for parking and waiting. Please see Picture a. Reversing cars block the footpath and put pedestrians at risk, this issue will be worsened by the availability of an additional facility with an offsite alcohol license.

D Scott & Wilson (Formally CU Insurance) is located on the corner of a busy junction. The introduction of additional outside seating next to that junction is planned. The area has been fenced off however this reduces visibility of traffic.

D Scott & Wilson do not have ownership of this area as as such do not have the right to claim this space without consulting neighbours and the local authority.

Public Health & Environment

1. Waste

It is well document that there are issues with waste collection of both commercial and domestic waste and as a result waste builds up in the back lane creating risk to public health. At present there is insufficient provision for the storage and collection of waste. The additional waste created by the Scott & Wilson both in normal commercial operations by also by customers of the venue is a significant concern. In the time I have lived in the area directly opposite a venue with an onsite license, specifically the Gunner and a takeaway facility waste has increased at weekends and included; food waste, food packaging, glass and bottles, Brocken glass and used condoms

Please also refer to Picture c which shows the back lane and the current provision for waste storage.

2. Noise

Given the proximity to residential properties and the type of construction of commercial and residential properties noise generated for this venue is a concern. Given that buildings where constructed before 1950 acoustic insulation are poor and noise pollution an issue. It is possible to hear conversations conducted at a normal speaking level noise outside properties. Noise from customers inside Scott and Wilson and live music within the venue is problematic, increasing capacity to accommodate social distancing and increasing seating outside will make this situation worse. Please note the intention to increase outside seating was verbally confirmed by Scott and Wilson employees and by the unlawful demarcation of land shown in picture b.

3. Toilet facilities & Hazardous waste

Scott & Wilson does not currently have enough toilet facilities to accommodate more patrons, those consuming alcohol in the area outside the venue will need to access to facilities in addition to those inside. Previously we have had an issue with people using the back lane and garden as a toilet. In summer this results in a strong smell of urine. Given we have an issue with waste collection this has been a significant risk to public health.

Anti-Social Behaviour

It is documented and evidenced that increased alcohol consumption results in increased levels of anti-social behaviour. I have lived opposite a public house for several years and have been impacted negatively by;

Fighting and assault
Shouting and swearing
Urinating in the back lane and in the gardens
Vadalism

An additional venue with an 'on and off site' license will increase levels of anti-social behaviour and have a significant impact on quality of life, community and on local business.

Property Prices

Property prices are impacted by a number of market drivers and economic conditions but are also impacted by the perception of an area in terms of;

Environment Safety

Crime Traffic & Transport links

Facilities Schools

The application by Scott & Wilson will impact on the perception of the areas in terms of Environment, Safety, Crime and Traffic by prospective buyers.

It will also impact on the 'actual' experience of neighbours in the local area. While we understand that it is important to support local business it is important that those business are a positive part of the local community. It is felt that the current proposal only represents the interests of the business and not of neighbours, others in the local business community and potentially on customers.

Having taken the time to clearly outline concerns and reason for our representation we would appreciate it if you would take the time to consider the points raised and take them into consideration in your decision making process.

The property is located within the North Shields area with residential apartments located above and adjoining at 3 Trevor Terrace and 11A Kirton Park Terrace. The premise operates as a café.

There will be a cumulative impact from an additional licensed premises within the area. Currently there is a public house "The Gunner" located opposite, a hot food takeaway, Fortune City, an off-licence and a general dealer adjoin on either side of the cafe. The granting of a premise licence for Scott and Wilson will result in additional noise within the area with associated external noise from the seating area later into the evening and an intensification of use of the premises by permitting the granting of the premise licence. Environmental health receive frequent complaints about cafes and public houses, specifically about amplified music, emptying of bottles into the refuse bins late at night and early morning noise from the collection of commercial refuse bins.

If external seating or smoking area was to be provided to the front of the premise this will result in noise from customer voice for the first floor residential flats. Environmental health receive frequent complaints about similar premises due to associated noise from the activity, specifically about loud voices from customers using the seating areas during the late evening.

If background music will be provided as part of the operation this will result in additional noise for the residential properties located above the premises. It is unclear on the construction of the existing ceiling between the café and residential flats and it is unclear if its construction will provide adequate sound attenuation for a licensed premises, although it is noted that the premises have operated for over a year with only 1 complaint being received by Environmental Health.

The proposed licensed premise application is requesting opening hours to 23:00 hours, If the premise licence is to be granted it is recommended that the operating times are

controlled to the requested hours to ensure local amenity impacts are reduced. Any external seating areas that may be provided should be restricted to 08:00 – 21:00 hours Monday to Sundays to minimise noise late evening for neighbouring residents.

Recommendation

I would recommend the following conditions:

1.0 Ensure the front doors, all fire exit doors and windows at the premises are kept closed except for access, egress or in the case of emergency.

Reason: To minimise noise breakout from the licensed premises to the residential premises.

2.0 Noise condition

The Licensee shall ensure that all noise arising from any licensable actives within the premises shall not exceed a level of 35 dB LAeq during daytime in the first floor residential flats at any time.

Reason: To minimise noise transmission from the licensed premises to the residential premises.

3.0 Opening Hours: to those on the application.

External Seating Areas

4.0 The use of the external seating area shall be restricted to 08:00 hours to 21:00 hours Monday to Sundays.

Reason: To minimise noise late evening for neighbouring residents.

5.0 Submit for approval in writing to the Licensing Authority a noise management scheme for the premises with regard to the use of the external seating areas and any smoking areas, detailing measures to be taken to minimise external noise, and thereafter implemented.

Dear Sir / Madam,

I am writing as over the last couple of weeks I have seen a new outdoor area appear outside of Scott and Wilson and it doesn't look like anyone has communicated to the residents about this. Yesterday I went over to the shop and noticed the public notice that the venue is now expanding to upstairs and increasing its capacity.

I have concerns around a few things: -

- 1) People being able to drink outside until 11.00pm I have two children (one at primary school) who have to go to sleep between 9.30 10.30pm and the new outside space is inevitably going to cause them disturbance. We have enough problems with The Gunner failing to move people indoors and police its outside area late at night and I think this is just going to increase the problems for us. I would like to request that people are asked to move into the premises by 10.00pm at the latest.
- 2) The opening of upstairs and increasing capacity Previously this premises was and insurance company and before that a sandwich shop both that were only open during the day. Turning this into a 100+ capacity bar seems like a real stretch in that location. There is going to be a lot more people leaving the premises after 11.00pm and more people smoking outside on street given there is a new outside area and more permanent benches on the street. Ultimately this means more noise for us at the wrong time of day.
- 3) Live Music It says in license application that there will be no live music. I would request that they stick to this as there have been live acts on previously with PA systems that are way too big for the size of venue. If its hot they open the doors and I can't get my children to sleep. Could you confirm there will be no live music at the venue from now please?

4) Social Distancing - I appreciate this is now an issue and this is part of the logic behind the expansion into the outside area. However, given that the 2m rule is now 1m is this still relevant and will this be a permanent change when social distancing is over? The Gunner has a beer garden which is part of its premises but moving people into a cobbled together outside space on the street (separate to premises) and putting new benches out on the other side of venue on street really doesn't feel like a sensible use of space in an already congested area. How is having lots more people close together on the street in a tight area with shops and take away next door going to help with social distancing in reality? Everyone spilling onto street and creating a new thoroughfare between venue and outside area will make social distancing more difficult for people using other shops and walking past.

Overall, it feels like a bit of an opportunistic land grab and given they are moving upstairs do they really need to move outside also? Do they not need to have permission *before* they start constructing the outside area?

It doesn't look like a well thought through project and I am very surprised it has been given council approval in this location and that construction has started without consultation from residents.

Sent you a video on another email and it would be good to know if you got it . I wrote to you a couple of weeks ago with some concerns about Scott and Wilson being able to serve drinks outside until 11.00pm and the video is a good example of why . The video is Saturday 11th at 22.40pm and my kids were woken up by singing and shouting which also turned into some really shocking language later on . I won't share this with you on email but some of the stuff coming out there mouths was ridiculous .

From what I believe The Gunner has to clear the outside area at 10.00pm so I have no idea why Scott and Wilson have been given permission to let people drink outside past this time. It makes no sense and you are going to create a big problem in that area for residents and other people passing that location if you leave it as it is. There is no monitoring of outside area and you can see from the video that people who are very drunk and noisy were not in anyway being asked to be quiet or come inside. I have another short video 10 mins later so you can see nothing has been done and they remained outside unchallenged and this went on for a good 30 - 40 mins.

Its not acceptable in a residential area and for them to expand onto street and say this is so they can practice social distancing is laughable.

If you could get back to me I'd appreciate it .
