- It's 'all age', 2021 to 2026; whole system approach
- Developed in consultation with parents, carers, young people and partners over a 2 year period;
- With ongoing support from Inclusion North, Healthwatch and the North Tyneside Parent Carer Forum;
- Strategically aligned it reflects the NHS Local 3 year plan and the National Autism Strategy;
- 6 high-level priorities have been agreed;
- Approved by Health and Wellbeing Board and Children's Board, Sept 2021
- Update on the first 10 months of delivery (started Oct 21)







Engagement

- A group of parents, carers and residents with lived experience who meet monthly to support the work programme;
- Includes young people a representative has joined the steering group called Louise;
- Supported by the Parent Carer Forum, Inclusion North and Healthwatch;
- This group are and will review the 'offer' as a critical friend, plus: mystery shopping, hints and tips for business, engagement events, considering training materials and sharing of best practice.

Priority 1. Good Support

Planned Year 1

- Community offer established
- Enhanced Information and Advice offer
- Establish disability employment support advisors
- Review Housing Forensic Housing options
- COVID support & vaccinations
- Workforce training / planning

- New commissioned community support framework 16+ years (2022 to 2027)
- Disability support advisors enhanced role
- Implemented a new dynamic support register with CAMHS
- Forensic housing £500k NHSE capital funding secured
- Specialist housing flagged with Housing strategy
- Tim Lamb Centre 'Worry Group' for age 7-12 with autism and anxiety
- Holiday Activity and Food (HAF) provision extended support to children with disabilities including autism
- COVID rollout and support to individuals and businesses from public health & commissioning flagging outbreaks



Priority 2. Understanding yourself

Planned Year 1

- Peer Support networks developed
- System-wide approach for young carers developed
- Support pathway for parent carers developed

- Work underway to develop a pathway tor parent carers
- Language & Communication Team training for mainstream schools to understand autism
- Additional funding agreed for Cygnet Training for parents being delivered
- CCG investment into 2 x new Sensory OT support – children's and adult's services
- Peer support development networks new NHS funding, to build knowledge and business case to kickstart peer networks



Priority 3. Raising Awareness

Planned Year 1

- Produce a set of principles
 / guide to reasonable
 adjustment for universal
 services
- Develop training and awareness raising materials

- Sessions about autism and carers added to core training for all staff
- Training added on Emotional Regulation, working with parent carers and autistic carers
- 2 staff supporting autistic people with mental health needs – working intensively in hospital to upskill staff on dual diagnosis
- Disability employment advisors links to Connexions and schools
- CAMHS provide language & communications team confirmed diagnosis for children living in North Tyneside



Priority 4. Being listened to

Planned Year 1

- Co production of the strategy with children, young people, adults with autism, families and carers
- Expand the role of the steering group to include young people
- Professionals listening to, understanding barriers and hearing the voice of people with lived experience

Progress to date

- Engagement group meeting regularry
- Young person to join steering group
- Roll out of more bespoke training for staff, linked to strength based assessment and key worker model.
- Connexions working with schools careers advice to young people who are autistic also NEET and/ or home educated
- Autism champion at the Front Door
- WLD team picking up transition cases Autism without an LD

Priority 5. Inclusive Communities

Planned Year 1

- Extend the digital offer
- Understand and refresh universal autism offer to all schools
- School champions developed
- Co produce and develop plans for an "Autism Friending Borough"

- Autism in Schools Project 4 mainstream schools: Percy Main Primary, Whitley Bay High School, New York Primary and Monkseaton Middle School.
- Work commencing with business and with key partners, Health, DWP, LA to consider the Good Employer pledge
- Universal offer in schools being developed with health
- Pre diagnosis support for families on waiting lists/ early help – joint approach across health & social care
- Mini Forums with families/ parent carers would like to see Autism Friendly Borough, parent carer forum doing visits to LA services check if autism friendly



Priority 6. Support through life changes

Planned Year 1

- Engagement with providers
- Targeted support from peers/ buddies or care services to support life changes
- Hospital discharge pathways
- Records flagged on health systems to enable better health care

Progress to date

- Provider Forums held quarterly, weekly newsletters, providers on steering group.
- Transitions advisory group meeting 2 weekly reviewing themes and removing barriers
- Hospital passport rolled out health looking at roll for social prescribing re early intervention.
- CCG investment e.g. STOMP (medication),
 OT's and Children's short break coordinator for 12 months
- Project Choice NHS England supported internships – "Ignite your Potential"

Case Study: Access to Employment



'North Tyneside Jobcentres have had positive results working with the Youth Employment Service North East run by North East Autism. Younger neurodiverse jobseekers have achieved concrete work outcomes such as traineeships, job starts and apprenticeships.

Wallsend Jobcentre has supported a nineteen year old jobseeker with autism with very little work experience to secure a DWP Kickstart work placement at Park Road Medical practice which is going well'.

- They offer support to other local providers and business developing Autism friendly sites.



Next Steps

- An end of year report will be shared at the Children's Board and HWB in Oct 2022 and across the partnership, to include outcomes and impact;
- Views of children, young people, parents and carers and adults with autism will be key;
- The steering group and work stream leads are starting to look at 23/24 programme, governance and refocussing of priority actions, meetings happening with lead partners.
- Autism pathways document being refreshed by health colleagues.
